## Community Description (Rev. 11/04/2023)

This five-year recreational plan is for the jurisdiction of Helena Township. It was developed by the Parks and Recreation Committee at the request of, and approved by the Helena Township Board. Our plan focuses on matters relating to parks and recreation on property owned by or under the jurisdiction of Helena Township currently and in the future.

Helena Township is located in the southern part of Antrim County. The township is bounded by Custer Township on the east and by Kalkaska County's Clearwater Township on the south. Torch Lake forms the western boundary while Clam Lake and the western portion of Grass River form a water boundary on the north.

Helena Township is the smallest township in Antrim County. It is only 19.5 square miles as opposed to the usual 36.0 square miles for most townships.

According to the U.S. Census Bureau's 2021 American Community Survey 5-year estimates, published as demographic information on the Antrim Co. website, there were 1114 people living in Helena Township.

- 1. 4% were under 9 years old or under
- 2. 8% were 10-19 years old
- 3. 8% were 20-29 years old
- 4. 8% were 30-39 years old
- 5. 9% were 40-49 years old
- 6. 15% were 50-59 years old
- 7. 21% were 60-69 years old
- 8. 20% were 70-79 years old
- 9. 6% were over 80 years old

Our community supports a high percentage of seasonal homes, and the township population shows a significant increase from May to September.

The large population of older adults and its influence on our planning and goals will be discussed later in our plan.

Commercial activity takes place in the Clam River area, in the unincorporated village of Alden, and in the southwest corner of the township (Crystal Beach Road and South East Torch Lake Drive). Commercial activity that occurs in the township is concentrated during the summer months.

# Administrative Structure (Rev. 11/04/2023)

The Township Planning Commission was established by the Helena Township Board under the authority of Public Act 157 passed in 1905. The purpose of the Helena Township Planning Commission is to oversee the orderly development of the township. It systematically reviews and revises the master plan and zoning ordinances. In addition, the Planning Commission researches pertinent land use topics and advises the Township Board on these issues.

The Helena Township Planning Commission encourages public participation through its regular public meetings, public hearings, and advisory committees, including the Parks and Recreation Committee. That committee drafted the Recreation and Natural Resource Plan for Helena Township, which was reviewed and approved by the Township Board. The Parks and Recreation Committee will advise and work with the township to implement the goals, objectives, and action steps in this plan.

Helena Township employs one part-time zoning administrator, and one assessor. The supervisor, clerk, treasurer and two trustees are paid elected officials. All township maintenance is contracted out, or performed by volunteers.

The primary source of funding for parks and recreation projects is included in an annual operating budget that is reviewed and approved by the Township Board. The Township Board has sole authority to commit funds for parks and recreation, accept grants, and purchase land on behalf of the community. For the budget year July 2023 through June 2024, \$50,690 was allocated for the Parks and Recreation Committee. This includes \$30,000 in maintenance costs, leaving \$20,000 that can be used for projects. Funding for the operation and maintenance of all parks comes from the General Fund of the township. That funding can be adjusted as allowed by law and available monies.

The community is very active and supportive through financial donations as well as donations of labor and materials for many smaller projects. Major projects such as Coy Mountain have been initiated through Michigan Department of Natural Resources Trust Fund (MDNRTF), the Grand Traverse Regional Land Conservancy, and grants as well as community donations and volunteer labor.

Helena Township is fortunate to have several active volunteer groups who invest in the Township. These groups have invested money and provided volunteers to improve parks within the township. We acknowledge the past efforts of all groups that have worked to ensure recreational venues and activities for Helena Township Helena Township Parks and Recreation

residents as well as visitors. The Parks and Recreation Committee looks forward to partnering with volunteer groups in future endeavors.

Helena Township and the Parks and Recreation Committee have also developed working relationships with a number of government agencies. Before any project is undertaken, the Parks and Recreation Committee would discuss plans with any government or private group that is likely to become involved.

## Inventory of Existing Parks, Natural Areas and Recreation Facilities (Rev. 11/04/2023)

Helena Township has many parks that provide opportunities for varied types of recreation. Upkeep and renovation at all sites is the responsibility of the township.

The unincorporated village of Alden is the center of activity with the exception of two private marina complexes in the northern part of the Township where Clam River enters Torch Lake.

In addition to the major Township-owned facilities described below, the Township has located within its boundaries the Grass River Natural Area owned by Antrim County, fourteen (14) public lake access sites and three (3) public launch sites.

- 1. Tennis Court Park was originally gifted to Helena Township by Hartley Comfort. It now has two fenced tennis courts which were renovated in 2017. Lines have been painted on these courts for both tennis and pickleball. There is a covered pavilion with electrical outlets. Running water is also available. There is a small gazebo with covered seating. Permanent restrooms are available May through October. Pet waste disposal bags are provided. An ADA compliant sidewalk leads to the restrooms and to the tennis/pickleball courts. There is an extensive play area with a variety of equipment. There is a separate designated toddler play area. Swings are in an area separate from the general play equipment. There is a concrete basketball court in the lower level of the park. There is a marked ADA approved parking space and a bike rack. The Township provides electricity and ongoing maintenance at the Park.
- 1. **Archie Valleau Landing** is adjacent to the north side of the Alden Safe Harbor and is a small wedge-shaped piece of shore land that was donated to the Township for recreational purposes. Archie Valleau Landing lacks accessibility by persons with disabilities. A concrete ledge approximately four to five inches high separates the paved parking area from the beach front. There is no opening at any point in this barrier. The parking lot adjacent to this park is paved and has one handicap only parking space. We believe that all parks in our township should be accessible. Responses to the public survey reinforce our desire for accessibility for all.

Responses in our public survey reflect a desire for continued and even increased park maintenance of existing park facilities. Archie Valleau Landing offers one of the few sandy public beaches on Torch Lake and is an access point for the Chain of Lakes Water Trail. One of the port-a-potties serving both Archie Valleau Landing and the Alden Safe Harbor is handicap accessible.

2. **Alden Safe Harbor** provides the only public boat docks on Torch Lake. It is a designated safe harbor. In our public survey, Alden Safe Harbor was identified as an important resource in our township.

Locating Alden Safe Harbor from a boat in the middle of Torch Lake has been made easier by the addition of a harbor light. This light greatly improves the chances of finding the safe harbor in the event of dangerous weather. When we asked for suggestions to improve our parks in the past, several people said they wanted improved signage about the features and attractions available in Helena Township. Since the Safe Harbor is an entry point for boaters visiting Alden, we believe improved signage and making the dock area more attractive would enhance the visitor's experience. One of the port-a-potties serving both Archie Valleau Landing and the Alden Safe Harbor is handicap accessible. Pet waste disposal bags are provided.

3. **Depot Park** is a varied site, including a 1908 railroad depot with over three acres contiguous to Torch Lake. The depot was acquired in 1986, restored to its original appearance and is now the Alden Depot Museum, which has been designated as a state historical site. The Museum is open with limited hours from Memorial to Labor Day. A portion of the depot museum's roof extends out forming a covered pavilion-like area for community events. The park is available for private events through a reservation system handled by Helena Township personnel.

A locomotive and several railroad cars located outside the museum can be explored by the public (during museum hours). A veteran's memorial is found in the southeast corner of the park and is handicap accessible.

The Park has one sand volleyball court and decking and steps for lake access. The Park has been landscaped and that is maintained by volunteers. It has viewing benches, picnic tables and grills.

The parking lot at Depot Park provides parking for the park, as well as boat trailer parking for people using the Alden Boat Launch.

An ADA accessible port-a-potty is available May to October. There are pet disposal bags at this park. The Township provides maintenance and electricity and takes care of cleanup and trash collection.

4. **Coy Mountain Forest Preserve** began with land originally given by the Reuben Coy Family. The intent was to preserve and protect the landscape in all its natural beauty. The desire was to maintain the trees, shrubs, flowers, and wild life indigenous to this area for the use and benefit of the residents

of Alden and the surrounding community. The original gift was supplemented by multiple donors, including the Grand Traverse Regional Land Conservancy (GTRLC).

In 2003 the Township, aided by a DNR Trust Fund Grant, acquired 2.7 acres of climax hardwood forest in the center of the existing 17 acres. In 2019 another 1.5 acres was added through a joint purchase of 3 adjoining lots. This purchase was completed in partnership with the GTRLC and resulted in a total acreage of 18.5 for Coy Mountain Preserve.

Trail development took place in several stages beginning in 1986 with members of the Youth Conservation Corps., the Alden Run Committee, local Boy Scouts, Traverse City Eagle Scout Bob Pennington, Helena Township board members and maintenance personnel, GTRLC, and the Alden Volunteers all playing a part in trail development and maintenance. The trails are approximately 1.6 miles long with an elevation difference of 180 feet. A trailhead sign and trail signs along the way make for easy navigation. Educational signs which identify unique trees are in place. Many large diameter red oak, sugar maple, beech, hemlock and basswood trees exist on the parcel. Coy Mountain is a place where people go to enjoy the natural beauty of a Northern Michigan forest.

- 5. Community Center houses the Township offices and Alden District Library. A kitchen, meeting rooms, gymnasium, and public restrooms are available for public use. The building is ADA compliant and provides a location for year-round uses such as family gatherings and indoor recreation. Uses include private gatherings, educational and enrichment programs, home school use of the gym, movies, yoga, pickleball, quilting, knitter's club meetings, basket making, Mah Jongh, bridge, and nonprofit fundraising. Remote operated doors provide handicap accessibility to the building and the restrooms.
- 6. The Helena Township Ball Park is a recreational area and access to Torch Lake approximately 6.2 acres in size. It is classified as a "Natural Resource Area" and is located on S EastTorch Lake Drive and the southeast shore of Torch Lake. Helena Township has created a master plan for this park. The park contains a ball field, dugout, permanent concrete bleachers, handicap accessible port-a-potty, and a Rubbermaid pump house. There is a special use area of the park on the shoreline of Torch Lake. It contains steps leading down to the water bordered by a split rail fence at the top. This area contains four picnic tables, four barbeque grills, and three refuse barrels. There is also a kayak launch slide system to assist kayakers in both entering

and leaving the water. This is also an access point for the Chain of Lakes Water Trail.

The baseball field is frequently used for playing ball. The shoreline area allows local residents and visitors to enjoy Torch Lake. Swimming, sun bathing, child and pet play activities, and picnicking are a few of the uses of this park. The park is available for private events through a reservation system handled by Helena Township personnel.

This park is not handicapped accessible. The parking lot is not paved and there are no designated handicap parking spaces. There are no paved pathways within the park. Without a ramp or railings the bleacher section is not handicapped paccessible. The port-a-potty is handicapped accessible. Pet waste disposal bags are provided.


There is no recreational grant associated with Helena Township Ball Park.

### **Inventory of Existing Parks, Natural Areas and Recreation Facilities** (Rev. 11/04/2023)

There are 14 road end lake accesses in Helena Township. Jurisdiction for these accesses was transferred from Antrim County to Helena Township in 2010 by Resolution No. 040810. These lake accesses are a valuable resource for our township. They allow both residents and visitors physical access to the three lakes in our township; Torch Lake, Clam Lake, and Thayer Lake. A short description of each access is given below:

- 1. (A) Union Street: located off N. Lake St.
- 2. (B) Tyler Street: located off N. Lake St.
- 3. <u>(C) Helena Street</u>: located at the west end of Helena Street, bordered by Archie Valleau Landing and the Alden Safe Harbor on Torch Lake.
- 4. (D) Franklin Street: located at the west end of Franklin Street and gives access to Torch Lake.
- 5. (E) Un-named access: located on South Lake Street with access to Torch Lake

#### NATURAL RESOURCE INVENTORY (Rev. 11/04/2023)

Fifty-four percent of Helena Township survey responders agree that acquiring land for future parks and/or open space is an action that will improve the park system. The Township will continue to evaluate land acquisition opportunities and will work with willing landowners and other public and private partners to acquire land that meets parks and recreation needs.

Based on the results of our public survey and input from other business and stakeholder groups, we have determined that the most desirable lands for acquisition would be the following:

- 1. Waterfront property on Torch Lake, Clam River, Thayer Lake and Spencer Creek.
- 2. Property contiguous with our existing parks which allow for expansion of those parks.
- 3. Scenic viewshed property.

# Waterfront property on Torch Lake, Clam River, Thayer Lake and Spencer Creek

We have identified several pieces of property in the vicinity of the Alden Safe Harbor that may be available for acquisition in the near future. Currently, these parcels are owned by the Alden State Bank. One parcel is contiguous to the Alden Safe Harbor and has frontage on Torch Lake. The others are connected to that parcel. Together, they would make a wonderful picnic area for the public and boaters to use. The description for these parcels is as follows:

In addition, there is one parcel located directly across the street (Coy St.) from those listed above that offers frontage on Spencer Creek. It is also owned by the Alden State Bank. The description for this parcel is as follows:

## DESCRIPTION OF THE PLANNING AND PUBLIC INPUT PROCESS (Rev. 11/04/2023)

In September of 2023 the Helena Township Parks and Recreation Committee notified residents that we would be conducting a survey during the period September 15 – October 31, 2023. Residents were given three ways to complete the survey. They could pick up a copy of the survey at the Helena Township Community Center, go online at <a href="www.helenatownship.com">www.helenatownship.com</a> and complete an electronic survey, or they could download a copy at the same website and mail or drop it off at the community center.

In addition, advertisements about the survey were placed in the two main newspapers that serve our township. Members of the Parks and Recreation Committee also made personal contacts to encourage residents to complete the survey.

A total of 41 households representing 65 people responded to the survey.

In addition to the survey, input was invited during the October, November and December meetings of the Parks and Recreation Committee.

Our committee believes we have gathered input from a broad range of residents, including those of all ages, and members of community organizations.

#### **Public Review of Draft**

Revision of the Helena Township Recreation and Natural Resource Conservation Plan was completed in November of 2023. In October of 2023, we placed adds in the two newspapers that serve our area and posted a notice on the Helena Township information bulletin board in the Community center asking residents to review the completed draft plan and submit comments to the Helena Township Parks and Recreation Committee during the period November 9 through December 12. They could review the plan in two ways:

- A. Review a hard copy of the plan at the Alden District Library
- B. Go online to the Helena Township Parks and Recreation website.

We gave residents three ways to comment on the draft plan:

- A. Mail comments to the Helena Township Parks and Recreation Committee.
- B. Email comments to the committee at helena@torchlake.com
- C. Bring comments to the public meeting to be held on December 13.

The Committee received no public comments on the plan during the period of November 9 through December 12. One person attended the December 13 meeting to provide input.

On the following pages in a grid format, we have stated our goals, objectives, and action steps for each park. A paragraph that provides support for the goals and objectives we used is included before each park's grid.

The goals we arrived at for the Helena Township Parks and Recreation 5-year-plan are based on information obtained from our survey of the residents, our contacts with people who use the parks and facilities, and observations and data collected by committee members. They are:

- 1. Promote a healthier and safer community for all age groups
- 2. Develop age appropriate recreational opportunities within Helena Township
- 3. Improved communication for residents and visitors about Helena Township parks and recreation facilities and activities
- 4. Improved access at all Helena Township Parks
- 5. Protection/preservation of natural areas and the environment

#### TENNIS COURT PARK

#### Accessibility and Safety:

Helena Township includes a large percentage of the population who are middle age to seniors. Census figures for 2021 state that 62% of our population is over age 50. Sixty-three percent of the people in households who responded to our public survey were age 55 or over. We believe that all the parks in our township should be accessible and safe for people in these age groups, regardless of their mobility challenges.

When we surveyed our parks for accessibility by the handicapped or disabled, only three were partially accessible; Tennis Court Park, Community Center, and Safe Harbor. The Tennis Court Park has one handicap parking space and accessible bathrooms, but no access to the play ground equipment and surrounding area, the swings, the gazebo, the pavilion, or the basketball court. The basketball court in this park is located on a lower level of the park which is approximately 12 to 15 feet below the main level. You can reach the court by walking down Tyler or Lake Streets. Our committee believes that improving accessibility and safety in Tennis Court Park must be a major priority.

Healthier community with recreational opportunities for all age groups:

Eight percent of our residents are under the age of 19 and 25% are between 18 and 49 years old according to 2021 census data. In our public survey, 12% of those in households responding were 19 years old or younger, and 22% were between 20 and 54. Over 83% of survey respondents said that Tennis Court Park is an important to very important resource. In addition, over 80% said they supported upgrading existing parks and 79% said they would like to see better maintenance of existing parks. When we asked which groups were underserved by our current recreation resources and programs, 24% said all groups are served adequately. However, of the remaining 76% over 29% answered seniors, 22% stated high school youths, and 38% believed people with disabilities were underserved. We believe that it is important to provide safe recreational opportunities for all age groups.

Forty-one percent of those responding to our public survey said they play pickleball at Tennis Court Park. Thirty Six percent said they would like to see additional pickleball courts. With the increasing popularity of pickleball and space available at this park, we need to look at installing additional courts.

# Helena Township Depot Park (Chessie's Pause) (Rev. 11/04/2023)

### Accessibility and Safety:

Depot Park was referenced by 84% of survey respondents as important or very important to this community. More than 85% of survey responders used the park from one to ten times during the past 12 months. As one of the most used facilities in Helena Township, concerns about safety and handicapped accessibility must be a priority.

Since our local population is predominantly over 50 years old, the park's handicapped accessibility should be improved to allow for older residents and those with mobility issues. Pathways to the observation decks at the southwest corner of the park and the brick platform in front of the depot building must be upgraded to allow those in wheelchairs or motorized scooters to access these areas. There should be an ADA accessible pathway to all facilities in the park. The Alden Depot Museum, located inside the building, is not accessible to those with mobility issues. The parking lot does not meet the ADA handicapped accessibility requirements.

#### **Healthier Community:**

During the past 5 years, the Helena Township Parks and Recreation Committee has discussed doing a master plan for Depot Park, which would include making all areas handicapped accessible.

#### **Improved Communication:**

The Helena Township Historical Society administers the museum and holds some standing events each year. Private individuals also use the park for events, and several local nonprofits also hold various events there. The Helena Township Board schedules all outdoor activities at the park through their office. We need to continue to maintain regular and open communication with those who use the park.

## COY MOUNTAIN PRESERVE (Rev. 11/04/2023)

In our public survey, over 87% of respondents said that Coy Mountain Preserve is important to very important to their family. Seventy-eight percent said they have used the facility between 1 and 10 times during the past 12 months. Clearly Coy Mountain Preserve is a valuable asset in our community.

One of the features lacking at Coy Mountain is accessibility for disabled persons. The parking area is not handicapped accessible. The trails are dirt, narrow and uneven. Parts of the park are hilly and could not be used by wheelchairs. However, other existing trails offer modest elevation changes and could easily be adapted to be handicapped accessible.

We need to shorten the interval of routine maintenance for the park to be sure that hazards such as fallen trees on the trail are removed immediately.

A few privately owned vacant parcels of land border Coy Mountain Preserve. Expanding the park by purchasing these properties would add to the overall experience of those using the park. In our public survey over 52% of respondents stated they agreed/strongly agreed with the action of the township "acquiring land for future parks and/or open spaces." Also, over 80% said they support redeveloping/upgrading existing parks to support a broader range of activities and over 72% said they agree/strongly agree with the township developing new trails.

Our Helena Township Board believes Coy Mountain Preserve is a wonderful resource for our township and the village of Alden. It offers a trail hiking experience within walking distance of the downtown and lake front areas.

HELENA TOWNSHIP COMMUNITY CENTER (Rev. 11/04/2023)
The Helena Township Community Center was rated as "important to very important" by over 96% of our survey responders.
